## Carpetball

Hello, my name is Robert Woodcock-Valentine. I am currently a life scout and member of troop 215. I am here today to propose an idea I had for my Eagle Scout service project. Last summer my troop camped at Wesleyan Woods and a particular activity caught my eye; Carpetball. Like my fellow troop member Connor McTaggart's Disc Golf project, Carpetball is a way for families/youth to connect, have fun, and create lasting memories without getting into trouble.

The Game is simple; two opponents stand at either end of the table, arrange five pool balls however they like, and roll the cue ball at the opposite sides' arrangement. There is a compartment at both ends of the table and when you strike an opponents ball it will fall into this compartment (Similar to bowling). Whoever's arrangement runs out first loses the game. This is a very popular activity found at campgrounds and parks.

## Dimensions:

The table will be approximately 2 and ¼ feet wide by 12 feet long with about 10 feet of playing area, remember - the playing surface stops 12 inches short of each end so that the balls can fall into the compartment.
